## RESOLUTION 2018-01

## OPPOSING THE PROPOSED ROAD TO THE AMBLER MINING DISTRICT

WHEREAS,	Ruby Tribal Council is the governing body of Ruby, a federally recognized Native Tribe; and
WHEREAS,	Ruby Tribal Council is empowered to negotiate with Federal, State and local governments, and others on behalf of the Tribe, to advise and consult with the representatives of the Departments of federal agencies on all activities that may affect the tribe; and
WHEREAS,	we have and interest in the preservation of our land, cultures, and peoples; and
WHEREAS,	since time immemorial, our people have subsisted in our region and have depended on healthy land, healthy water, and healthy fish and wildlife resources to support our subsistence way of life; and
WHEREAS,	we have an inherent human right to that subsistence; and
WHEREAS,	we have been successful stewards of this environment and these subsistence resources for thousands of years; and
WHEREAS,	we have trust and responsibility to the generations that will follow us; and
WHEREAS,	our elders have taught us to think beyond the present and measure the effects into the future, to future generations; and
WHEREAS,	our subsistence resources guarantee our way of life and culture will continue for future generations; and
WHEREAS,	multiple mining companies are stalking claims in the Ambler mining district; and
WHEREAS,	mining for mere financial gain poses new threats to the survival of our subsistence resources and our people themselves; and
WHEREAS,	those mining companies are exploring for sulfide minerals, which will create acid that will result in toxic heavy metals polluting our lands and waters; and
WHEREAS,	building the road may also require using asbestos-laden soil, which could affect our health and the health of our subsistence resources; and

whereas, the road and mine will detrimentally impact water quality, caribou, sheefish, and other subsistence resources that we depend on for our very survival; and

whereas, our elders have held steadfast against this road development for multiple generations, asserting their inherent rights to subsistence and our way of life; and

**NOW THEREFORE BE IT RESOLVED,** that Ruby Tribal Council does hereby oppose the road to the Ambler Mining District; and

**BE IT FURTHER RESOLVED,** Ruby Tribal Council calls upon all those with trust responsibilities to our native peoples to stand with us in opposing this project; and

**BE IT FURTHER RESOLVED,** we shall seek to educate not only our tribal citizens but all citizens as to our collective fiduciary trust responsibility to all future generations to protect our natural resources, our environment, our subsistence resources, and our way of life.
